CAMROSE REGIONAL EXHIBITION AND AGRICULTURAL SOCIETY 50/50 RAFFLE RULES - 2024

- Licensee: The 50/50 Raffle (the "Raffle") shall be conducted by the 50/50 Licensee pursuant to a licence (the "Licence") from the Alberta Gaming and Liquor Commission ("AGLC") and in accordance with the Criminal Code of Canada, Alberta Gaming and Liquor Act and Regulations, AGLC Policy, AGLC Raffle Terms and Conditions, and the terms of the 50/50 Raffle Licensee Agreement between the 50/50 Licensee and Ascendfs Canada, Ltd (the "Service Provider").
- 2. Ticket Sales: Tickets will be sold online at <u>www.cre.ab.ca/5050</u> and in person on site at various stationary locations on the grounds as well as with roaming sellers.
- 3. Date and Location of Draw(s): The draw will take place by Random Number Generation ("RNG") online at <u>www.cre.ab.ca/5050</u>. The dates of the draws will be August 1, August 2, August 3, August 4, 2024. The draw will take place in the CRE Offices located at 4250 Exhibition Drive, Camrose, AB. The draws are open to the public.
- 4. Rules: These are the official 50/50 Raffle Rules and are available upon request.
- 5. Eligibility: The Raffle is open to all persons who are in the Province of Alberta when purchasing tickets. Ticket purchasers, whether online or in person, must be 18 years of age or older. Employees of the Service Provider and members of the 50/50 Camrose Regional Exhibition gaming committee are NOT eligible to participate (defined as purchase tickets or receive prizes) in the 50/50 Raffle.
- 6. Ticket Purchasers: If more than one name is written on a winning ticket stub, the prize will be awarded to only one of the individuals named on the ticket stub. Neither the Camrose Regional Exhibition (CRE) nor the Alberta Gaming Liquor and Cannabis (AGLC) is responsible for any disputes between the individuals whose names are written on the ticket stub.
- **7. Minor Children**: Adult ticket purchasers are not to give their ticket to a person under the age of eighteen (18) years as required by the Public Trustees Act.
- 8. Tickets: Ticket Pricing shall be as follows: Regular: Five dollars (\$5.00) for one (1) Number. Total Numbers 19,000 Discount 1: Ten dollars (\$10.00) for ten (10) Numbers. Total Numbers 150,000 Discount 2: Twenty dollars (\$20.00) for sixty (60) Numbers. Total Numbers 750,000 Discount 3: Fifty Dollars (\$50.00) for two hundred (200) Numbers. Total Numbers 2,000,000
- **9.** No Refunds: All ticket sales are final. There will be no refunds issued to anyone for any reason. All tickets purchased and entered the draw cannot be refunded, including if ticket purchasers made an error in selecting the amount of tickets they desire to purchase.

- **10.** How to purchase online: Visit <u>www.cre.ab.ca/5050</u> during the 50/50 Licenced Event and follow the directions to purchase and print the tickets for the Raffle:
 - (a) The initial landing page <u>www.cre.ab.ca/5050</u> is where the rules and cause of the 50/50 are explained. The button that says "PLAY NOW" will take ticket purchasers to the purchase portal section of the page.
 - (b) In the purchase portal section, ticket purchasers:

i Select a price point for purchase and the quantity of that price point.

ii Enter necessary personal information for purchase and agree to raffle terms and conditions; and

iii Enter their credit card information for purchase.

- (c) If the transaction is approved the ticket purchaser will receive a confirmation message and order ID followed by an email containing the ticket PDF as well as numbers on the ticket in the body of the message. It can take several hours for the ticket purchaser to receive their e-mail confirmation. Ticket purchasers are required to enter their e-mail address correctly with no errors when purchasing to ensure they receive their tickets and should check their spam and junk mail folders if they have not received their tickets several hours after their time of purchase.
- (d) If the ticket purchaser has not received their ticket by 9 am MDT the day following the 50/50 Licenced Event, they can email resents a before Noon MDT the day following the 50/50 Licenced Event to request that their tickets be resent. They must e-mail from the same e-mail they purchased tickets with. Tickets will be resent between Noon 3 pm MDT the day following the 50/50 Licenced Event.

Ticket Purchasers purchasing Raffle tickets online must fully complete their purchase using the procedures specified above. All online purchases are subject to and will be treated in a manner consistent with the Website terms of use and privacy policy.

- 11. How to purchase Tickets on the CRE site: Tickets may be purchased on the CRE site starting at the following times; Thursday August 1,2024 12:00 noon, Friday Aug 2, 2024 Sunday Aug 4, 2024 10:00 am. Tickets will be sold at a variety of stationary booths on site and by roaming sellers during the ticket sales window. Ticket sales in person will stop at the same time as ticket sales online. On site tickets can be purchased with cash, debit, Mastercard and Visa. Ticket purchasers will choose what price point and what quantity of that price point the purchaser wants. The sellers will then enter that information into the handheld machines. Tickets will be printed at the time of purchase and provided to the purchaser.
- **12. Technical Difficulties:** All methods of purchase may not be available at all times. If the System experiences any technical difficulties during an event or in the event virus, bugs, unauthorized human intervention, or other causes corrupt administration, security, fairness, integrity or proper operation of the Raffle (or any portion thereof), Camrose Regional Exhibition and Agricultural Society reserves the right in its sole discretion to: (i) cancel the Raffle; or (ii) suspend the Raffle until the problem can be remedied, whereupon it will resume. Without limiting the

generality of the foregoing, in the event of a cancellation or suspension, Camrose Regional Exhibition and Agricultural Society reserves the right, in its sole and absolute discretion, to elect to identify a winner and award the prize by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation or suspension.

- 13. The Draw: For the first draw on Thursday August 1, 2024 the online tickets will be available for purchase starting at 10:00 AM MDT and in person sales will start on Thursday August 1, 2024 at 12:00 noon. For the second draw on Friday August 2, 2024, the online ticket sales and the in person sales will be available for purchase starting at 10:00 am MDT. For the third draw on Saturday Aug 3, 2024 the online ticket sales and the in person sales will be available for purchase starting at 10:00 am MDT. For the third draw on Saturday Aug 3, 2024 the online ticket sales and the in person sales will be available for purchase starting at 10:00 am MDT. For the fourth draw on Sunday August 4, 2024 the online ticket sales and the in person sales will be available for purchase starting at 10:00 am MDT. For the fourth draw on Sunday August 4, 2024 the online ticket sales and the in person sales will be available for purchase starting at 10:00 am MDT. For all four draws, both online and on site sales will close at 9:00 PM MDT on August 1, 2, 3, and 4. The draw shall take place after sales close, at approximately 9:15 PM MDT at Camrose Regional Exhibition and Agricultural Society's office (4250 Exhibition Drive Camrose, AB). The winning ticket will be selected via Random Number Generator ("RNG").
- 14. Winner Notification: The winning ticket number will be posted on the Camrose Regional Exhibition 50/50 website at www.cre.ab.ca/5050 no later than 11:59PM MDT on the day of the draw. In the case of a discrepancy between the posted number and the actual number selected through Random Number Generation, the actual number selected through Random Number Generation will be the valid winning number.

The holder of the ticket containing the winning number will have 7 (seven) days from the time of the announcement of the winning ticket number to present the ticket containing the winning raffle number to the 50/50 Licensee. If the ticket is purchased online, the Camrose Regional Exhibition receives the purchasers name, email address and phone number and will make every effort to contact the winner after 2 days. If the winner purchases the ticket in-person, the name, email address and phone number are not collected and it becomes the sole responsibility of the winner to contact the Camrose Regional Exhibition.

Ticket purchasers may not transfer their tickets to anyone else prior to claiming the prize. The holder of the ticket containing the winning number may claim their prize by contacting the 50/50 Office at <u>5050@cre.ab.ca</u> and forwarding their purchase e-mail and a copy of their government issued photo identification and address. **PLEASE PUT PRIZE WINNER IN THE SUBJECT LINE**. If the winning ticket is from an in-person sales, the winner must bring the physical ticket into the office of the Camrose Regional Exhibition along with their government issued photo identification, so the ticket can be verified. Each prize claimant must provide Camrose Regional Exhibition and Agricultural Society with all information required by provincial gaming regulations to claim a prize. The prize claimant will be required to sign a Declaration and Release ("Release") which must be executed and returned to Camrose Regional Exhibition and Agricultural Society no later than five (5) business days after his/her receipt of the Release. The winner's name will be publicized on <u>www.cre.ab.ca/5050</u> and on various social media channels belonging to the licence holder.

The winner will receive a cheque within thirty (30) days of the winner delivering the ticket containing the winning raffle number, executed Release, and all other required documents to the Camrose Regional Exhibition and Agricultural Society.

If a prize is not claimed on or before the Prize Claim Expiry Date of 7 (seven) days from the time of the announcement of the winning ticket number – the prize will be forfeited. The Camrose Regional Exhibition will advise AGLC in writing and request authorization to retain the unclaimed prize money to be used as a use of proceeds or to donate the money to a charity approved by AGLC.

15. The Prize: In each Raffle the Prize will be 50% of the gross revenue from all tickets sold. Prize is not transferable and must be accepted as awarded with no substitutions, except at the 50/50 Licensee's sold discretion. The Prize shall be paid by cheque from the 50/50 Licensee. The designated winning raffle number contained in the ticket purchaser's 50/50 ticket is validation for claiming the Prize. In the event that multiple names are listed by the ticket purchaser, the first name listed will be considered the winner by the Licensee and the payable amount will be made out to that specific person only.

Unauthorized persons copying, selling or altering tickets are subject to prosecution. A 50/50 Raffle ticket will be void and a Prize not paid/redeemed if there is proof that the ticket was stolen, not issued, ineligible, altered, counterfeit, defective, printed in duplicate, or printed/produced in error. The Service Provider and the 50/50 Licensee are not responsible for lost or stolen tickets or tickets redeemed in error by their agents. All tickets, transactions and winners associated with the 50/50 Raffle are subject to the rules, regulations and procedures put in place by the 50/50 Licensee and the lawful charges thereof.

- **16. Power Failure:** in the event of a power failure, the draw will still take place as scheduled. Because the system is cloud based it can be accessed by one of the ERS's cellular devices to complete the draw
- **17. Cancellation:** The 50/50 Licensee may rescind, cancel, amend, or revoke the Raffle, subject to the prior approval of AGLC. Without limiting the generality of the foregoing, the 50/50 Licensee reserves the right to cancel or modify the Raffle and/or these Official Rules, in whole or in part and without notice, if the 50/50 Licensee determines that fraud or technical or other failures have threatened or destroyed the integrity of the Raffle.
