

CAMROSE REGIONAL EXHIBITION AND AGRICULTURAL SOCIETY
BVJ VIP EXPERIENCE
RAFFLE RULES - 2026

- 1. Licensee:** The BVJ VIP EXPERIENCE Raffle (the “Raffle”) shall be conducted by the Camrose Regional Exhibition and Agricultural Society Licensee pursuant to a licence (the “Licence”) from the Alberta Gaming and Liquor Commission (“AGLC”) and in accordance with the Criminal Code of Canada, Alberta Gaming and Liquor Act and Regulations, AGLC Policy, AGLC Raffle Terms and Conditions, and the terms of the BVJ VIP EXPERIENCE Raffle Licensee Agreement between the Camrose Regional Exhibition and Agricultural Society Licensee and Ascendfs Canada, Ltd (the “Service Provider”).
- 2. Ticket Sales:** Tickets will be sold online only at <https://cre.ab.ca/vipraffle> . Tickets will be available for purchase starting Thursday July 30, 2026 at 10:00 am . Tickets will be available for sale online until December 11, 2026 at 12:00 noon.
- 3. Date, Times and Location of Draw(s):** The draw will take place at 3:00 pm on Friday December 11, 2026 at the Camrose Regional Exhibition Administration Office – 4250 Exhibition Drive, Camrose, Alberta T4V 4Z8. The draw is open to the public.
- 4. Rules:** These are the official BVJ VIP EXPERIENCE Raffle Rules and are available upon request.
- 5. Eligibility:** The Raffle is open to all persons who are in the Province of Alberta when purchasing tickets. Ticket purchasers must be 18 years of age or older and the name of a minor must not be written on the ticket. If it is determined prior to the draw that a ticket has been issued to a minor, the ticket is deemed void and the purchaser refunded. Employees of the Service Provider and members of the Camrose Regional Exhibition gaming committee are NOT eligible to participate (defined as purchase tickets or receive prizes) in the BVJ VIP EXPERIENCE Raffle.
- 6. Ticket Purchasers:** If more than one name is written on a winning ticket stub, the prize will be awarded to only one of the individuals named on the ticket stub. Neither the Camrose Regional Exhibition (CRE) nor the Alberta Gaming Liquor and Cannabis (AGLC) is responsible for any disputes between the individuals whose names are written on the ticket stub.
- 7. Minor Children:** If it is determined prior to the draw that a ticket has been issued to a minor, the ticket is deemed to be void and the purchaser refunded. If the draw occurs and it is determined the prize winner is under 18 years of age, the ticket is deemed void, and a second draw will take place.
- 8. Tickets:** Tickets will be sold for \$20.00/ticket. The total number of tickets for sale will be 4999 tickets for a total ticket value of \$99,980.00.

- 9. Minimum Tickets Required:** A minimum of 1500 tickets must be sold for the raffle to proceed before the Camrose Regional Exhibition may apply for an extension of the draw date or cancellation of the raffle. These decisions are subject to approval of AGLC.
- 10. No Refunds:** All ticket sales are final. There will be no refunds issued to anyone for any reason. All tickets purchased and entered the draw cannot be refunded.
- 11. How to purchase online:** Visit <https://cre.ab.ca/vipraffle> during the BVJ VIP EXPERIENCE raffle sales Licenced Event and follow the directions to purchase and print the tickets for the Raffle:
- (a) The initial landing page <https://cre.ab.ca/vipraffle> is where the rules and cause of the BVJ VIP EXPERIENCE raffle are explained. The button that says "PLAY NOW" will take ticket purchasers to the purchase portal section of the page.
 - (b) In the purchase portal section, ticket purchasers:
 - i Insert or choose the quantity of the \$20.00 tickets that the purchaser wants
 - ii Enter necessary personal information for purchase and agree to raffle terms and conditions; and
 - iii Enter their credit card information for purchase.
 - (c) If the transaction is approved the ticket purchaser will receive a confirmation message and order ID followed by an email containing the ticket PDF. It can take several hours for the ticket purchaser to receive their e-mail confirmation. Ticket purchasers are required to enter their e-mail address correctly with no errors when purchasing to ensure they receive their tickets and should check their spam and junk mail folders if they have not received their tickets several hours after their time of purchase.
 - (d) If the ticket purchaser has not received their ticket by the next day, they can email resendvipraffle@cre.ab.ca to request that their tickets be resent. They must e-mail from the same e-mail they purchased tickets with.

Ticket Purchasers purchasing Raffle tickets online must fully complete their purchase using the procedures specified above. All online purchases are subject to and will be treated in a manner consistent with the Website terms of use and privacy policy.

- 12. Technical Difficulties:** All methods of purchase may not be available at all times. If the System experiences any technical difficulties during an event or in the event virus, bugs, unauthorized human intervention, or other causes corrupt administration, security, fairness, integrity or proper operation of the Raffle (or any portion thereof), Camrose Regional Exhibition and Agricultural Society reserves the right in its sole discretion to: (i) cancel the Raffle; or (ii) suspend the Raffle until the problem can be remedied, whereupon it will resume. Without limiting the generality of the foregoing, in the event of a cancellation or suspension, Camrose Regional Exhibition and Agricultural Society reserves the right, in its sole and absolute discretion, to elect to identify a winner and award the prize by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation or suspension.

13. The Draw: There will only be one draw made. The draw will take place on Friday December 11, 2026 at 3:00 pm MDT at Camrose Regional Exhibition and Agricultural Society's office (4250 Exhibition Drive Camrose, AB). The winning ticket will be selected via Random Number Generator ("RNG").

14. Winner Notification: The winning ticket number will be posted on the Camrose Regional Exhibition BVJ VIP EXPERIENCE raffle website at <https://cre.ab.ca/vipraffle> no later than 11:59PM MDT on the day of the draw. In the case of a discrepancy between the posted number and the actual number selected through Random Number Generation, the actual number selected through Random Number Generation will be the valid winning number.

The winner will have 90 (Ninety) days from the time of the announcement of the winning ticket number to claim their prize. Because the ticket is purchased online, the Camrose Regional Exhibition receives the purchasers name, email address and phone number and will make every effort to contact the winner after 2 days. In the event that the winner can not be located or contacted after the 90 days, the prize shall be forfeited. The Camrose Regional Exhibition will advise AGLC in writing and request authorization to donate the prize to a charity approved by AGLC.

Ticket purchasers may not transfer their tickets to anyone else prior to claiming the prize. The holder of the ticket containing the winning number may claim their prize by contacting the BVJ VIP EXPERIENCE office at resendvipraffle@cre.ab.ca and forwarding their purchase e-mail and a copy of their government issued photo identification and address. **PLEASE PUT PRIZE WINNER IN THE SUBJECT LINE.** Each prize claimant must provide Camrose Regional Exhibition and Agricultural Society with all information required by provincial gaming regulations to claim a prize. The prize claimant will be required to sign a Declaration and Release ("Release") which must be executed and returned to Camrose Regional Exhibition and Agricultural Society no later than five (5) business days after his/her receipt of the Release. The winner's name will be publicized on and on various social media channels belonging to the licence holder.

15. The Prize: The prize is awarded as listed. No Cash Value. The prize is the use of a VIP Tent for 20 people and 5 VIP camping spaces at the 2027 Big Valley Jamboree, prize value of \$22,500.00. The winner will be contacted by the BVJ office closer to the 2027 event. The winner will be responsible to provide the names of participants who will be attending the tent and the names of those camping in the VIP area to BVJ in order for them to process the proper tickets.

16. Unauthorized persons copying, selling or altering tickets are subject to prosecution. A Raffle ticket will be void and a Prize not paid/redeemed if there is proof that the ticket was stolen, not issued, ineligible, altered, counterfeit, defective, printed in duplicate, or printed/produced in error. The Service Provider and the Raffle Licensee are not responsible for lost or stolen tickets or tickets redeemed in error by their agents. All tickets, transactions and winners associated with the Raffle are subject to the rules, regulations and procedures put in place by the Licensee and the lawful charges thereof.

- 17. Power Failure:** in the event of a power failure, the draw will still take place as scheduled. Because the system is cloud based it can be accessed by one of the ERS's cellular devices to complete the draw
- 18. Cancellation:** The BVJ VIP EXPERIENCE raffle Licensee may rescind, cancel, amend, or revoke the Raffle, subject to the prior approval of AGLC. Without limiting the generality of the foregoing, the BVJ VIP EXPERIENCE Licensee reserves the right to cancel or modify the Raffle and/or these Official Rules, in whole or in part and without notice, if the BVJ VIP EXPERIENCE Licensee determines that fraud or technical or other failures have threatened or destroyed the integrity of the Raffle.
